MARCH 18, 2020 THROUGH APRIL 1, 2020**

The Covid-19 (Corona Virus) can only be slowed by “Social Distancing” and practicing “Safe Precautions” by all means possible.

Through careful consideration to community, tribal members, employees, and patrons to Comanche Nation Businesses. The Business Committee of the Comanche Nation will:

1. Close all Casino’s owned and operated by the Comanche Nation.
 - a. Certain Staff will be assigned to cleaning and re-modifications.
 - b. Certain Staff with children have options to stay home with - pay.
 - c. Upper management will be engaged in day to day duties.
2. Close non-essential social programs within the Government.
 - a. Certain Staff with conditions have options to stay home with – pay.
 - b. Certain Staff with children have options to stay home with – pay.
 - c. In house providers will stay open
 - d. Law Enforcement will stay open.
 - e. The Court will stay open with Head Judge recommendations.
 - f. Essential personnel will be at the discretion of the Administrator.
 - g. Outreach Centers will be closed.
 - h. Any events scheduled within Comanche Nation Tribal facilities are henceforth cancelled.
 - i. The Elder Center will be closed to congregate dining and will serve “take-out” meal options for existing participants.
 - j. The Food Distribution Program will remain open to qualified/existing participants.
 - k. Participants of the Diabetes Program and the Prescription Assistance Program will be assisted by calling the Emergency Management Hotline Number: 580- 492- 3628.
 - l. The Funeral Home will continue normal business operations with the implementation of certain restrictions.
 - m. Transit will be open Mondays, Wednesdays and Fridays from 7:30am- 4:30pm for current dialysis patients.
 - n. The CHR Program will service current dialysis patients.
 - o. All Child Care facilities will be closed.
3. Retail/Wholesale will operate as usual with safety precautions.
4. Comanche Nation Enterprises will operate as usual.

5. Gaming Commission will be at the discretion of Commissioners.
6. Housing will be at the discretion of Commissioners.
7. CN Emergency Management will be in full force during this time.
8. Business Committee will be in full effect during this time. Meetings will practice limitations of meeting to ten (10) people.
9. Four (4) Tribes “Declaration of Preventive Measure” will stay in effect until further notice, namely, the decrease curve of “virus spike”
10. United States President “Call to Action” is in full force.

The Comanche Nation Constitution dictates within; Article 6, Section 7. The duties, responsibilities and authorities of the business committee shall include the following: (j) To promulgate and enforce ordinances and codes governing law and order to protect the peace, health, safety, and general welfare on land determined to be within Comanche tribal jurisdiction.
