WEDNESDAY, APRIL 1, 2020 THROUGH WEDNESDAY APRIL 8, 2020 THEN  
WEEK TO WEEK**

The COVID-19 (Corona Virus) can only be slowed by "Social Distancing" and practicing  
"Safe Precautions" by all means possible.

- 1. Comanche Nation Gaming will be in full closure.**
- 2. Comanche Nation Government will be; essential services only.**
- 3. CBC Monthly Meeting will be moved to 04/18/2020.**
- 4. The Comanche Nation Annual Meeting will tentatively be moved to a date within the Comanche Nation Constitutional guidelines.**
5. Tax Commission will be at the discretion of Commissioners.
6. Retail/Wholesale will operate as usual with safety precautions.
7. Comanche Nation Enterprises will operate as usual.
8. Gaming Commission will be at the discretion of Commissioners.
9. Housing will be at the discretion of Commissioners.
- 10. CN Emergency Management will be limited to 3 days a week.**
- 11. Business Committee will be in full effect during this time. Meetings will practice limitations; teleconference only.**
- 12. CN Emergency Hotline will remain open, readied for any new emergency.**
13. Four (4) Tribes "Declaration of Preventive Measure" will stay in effect until further notice, namely, the **CONTINUAL** decrease curve of "virus spike"
- 14. United States President, "SOCIAL DISTANCING UNTIL April 30, 2020", is recognized and acknowledged.**
- 15. Continued "State of Emergency" extended one more week. Then week to week.**

The Comanche Nation Constitution dictates within; Article 6, Section 7. The duties, responsibilities and authorities of the business committee shall include the following: (j) To promulgate and enforce ordinances and codes governing law and order to protect the peace, health, safety, and general welfare on land determined to be within Comanche tribal jurisdiction.

The Comanche Nation Business Committee this **30<sup>th</sup> day of March, 2020** does exercise our responsibility to protect the peace, health, safety, and general welfare on our lands within the Comanche Nation jurisdiction by these updated actions outlined.
