Comanche Business Committee Meeting Procedures Code

I. Purpose

- a. The purpose of these procedures is to govern the conduct of meetings (whether special or monthly meetings) of the Comanche Business Committee ("CBC").
- b. No formal and binding action of the CBC may be taken except at a monthly meeting or duly noticed and convened special meeting, at which a quorum of five (5) CBC members are present.
- c. The CBC may meet to discuss items at informal work sessions. The purpose of these work sessions is discussion only, no formal or binding action shall be taken at such work sessions. Remote attendance at such work sessions shall be permitted. Work sessions shall be open to the Tribal Council, unless the requirements for executive session in Section VII are met, or a Tribal Council member is disruptive or disorderly.

II. Tribal Council Attendance at CBC Meetings

- a. Tribal Council members have a right to receive notice of and attend CBC meetings. Notwithstanding the foregoing, if a Tribal Council member is creating a serious disturbance, he or she may be required to leave the meeting by the Presiding Officer. CBC meetings shall be livestreamed (unless the technology necessary to livestream is not functioning for unforeseeable reasons). Provided; however, that the CBC may enter executive session for the reasons set forth in Section VII below.
- b. Paper copies of the tentative agenda and related resolutions shall be available to Tribal Council members in attendance on a first-come, first-served basis.
- c. The final agenda, approved open session minutes, enacted resolutions (redacted as appropriate, see footnote 4), and motions passed shall be made available online to Tribal Council members through the Comanche Nation website.

III. Setting the Agenda

- a. The agenda for CBC meetings shall be as follows:
 - i. Call to order
 - ii. Roll call
 - iii. Invocation
 - iv. Officer's Reports
 - 1. Chairman¹
 - a. The Chairman's Report must include any meetings or consultations attended in an official capacity with local, state, or federal governments, governmental units, or government officials.

2. Vice-chairman

 The Vice-Chairman's Report must include any meetings or consultations attended in an official capacity with local,

¹ Gendered language in these procedures shall apply regardless of the gender of the person occupying an office or position. For example, references to the Chairman include both male and female persons elected to the position of Chairman.

state, or federal governments, governmental units, or government officials.

3. Secretary/Treasurer

- a. Secretary/Treasurer's Report must include the following:
 - i. Statement of whether the Nation's gross revenue is presently over or under budget, and short explanation as to why.
 - Statement of whether the Nation's expenses are presently over or under budget, and short explanation as to why.
 - iii. Statement of whether the Nation's net revenue is presently over or under budget, and short explanation as to why.
 - Disclosure of any unanticipated expenses for the Nation, including both Tribal Government and Comanche Nation Entertainment, of over \$50,000.00.

v. Tribal Administrator's Report

- 1. The Tribal Administrator's Report must include a report on:
 - Total number of each of resignations, terminations, and new hires.
 - b. Job openings, and Requests for Proposals.

vi. Tribal Attorney's Report

- 1. The Tribal Attorney's Report² must include a report on the number of pending lawsuits to which the Nation is a party, claims asserted in each lawsuit, the potential damages in each lawsuit, and amount of fees billed for each lawsuit in the preceding month.
- vii. New Business
- viii. Old Business
- ix. Tribal Council Remarks
- x. Adjourn

b. New Business

- i. Requests to be on the agenda as New Business
 - CBC members, the Tribal Administrator, the Tribal Attorney, any tribal member, any tribal employee, any Comanche Nation Enterprise employee, and/or any Comanche Nation Entertainment employee may request an item to be placed on the agenda by emailing agenda@comanchenation.com. If you request to be on the agenda,

Notwithstanding any report or opinion required to be provided in these procedures, all other Tribal Attorney communications, memoranda, or other documents regarding the same subject matter shall be entitled to protection from disclosure under the attorney-client privilege, work product doctrine, and any other applicable evidentiary privilege or protection.

- it is strongly encouraged that you have a specific action item (e.g., resolution, motion) that you are requesting from the CBC.
- 2. Persons other than those listed in Section III(b)(i)(1) above may request to be on the agenda with the support of an enrolled member of the Comanche Nation.
- 3. Requests to be on the agenda must be submitted by 5:00 pm on the 15th day of the calendar month preceding the monthly CBC meeting at which the person is requesting to be on the agenda. Late requests will be considered if emergency or exigent action of the CBC is required, if the condition creating the emergency or exigency arose after the 15th day of the preceding calendar month and the person requesting to be placed on the agenda submitted a request within a reasonable time after the condition arose.

ii. Straw Poll Work Session

- 1. The Tuesday prior to each CBC meeting, the CBC shall meet informally either in-person or virtually to discuss the agenda at a work session. At such work session, a straw poll shall be taken regarding each request submitted to be on the agenda. Votes at the straw poll are non-binding (i.e., a CBC member may change his or her vote if a formal motion to approve the agenda is made at the monthly CBC meeting) and merely for the purposes of efficiency in formally approving new business portion of the agenda at the monthly CBC meeting.
- The results of the straw poll shall be publicly posted (such as by posting online). The results shall indicate the name and title of each CBC member voting on each proposed new business agenda item, e.g.:
 - a. Agenda Item #1
 - In favor: CBC 1 John Doe, Vice Chairman Jane Roe, Secretary-Treasurer Jim Doe
 - ii. Oppose: CBC 2 John Roe, CBC 3 Jim Roe
 - iii. Abstain: CBC 4 Jane Doe
- 3. If a question is raised regarding the legal authority of the CBC to take an action, any member of the CBC may ask the Tribal Attorney for a privileged opinion on the existence of such authority. If the Tribal Attorney's opinion is that the CBC lacks authority to take proposed action, a straw poll shall not be taken, but instead the publicly posted straw poll shall state that the item was rejected by the Tribal Attorney, e.g.:
 - a. Agenda Item #2—rejected by Tribal Attorney³

³ Nothing herein shall be construed as a waiver or abrogation of the attorney-client privilege, work product doctrine, or other evidentiary privilege or protection attached to attorney-client communications or attorney work product.

c. Old Business

i. Any item that was tabled at a prior CBC meeting shall be placed on the agenda as old business.

d. Tribal Council Remarks

- i. Following old business, any member of the Tribal Council may request to be recognized.
- ii. Once recognized, a Tribal Council member may ask questions, note concerns, or provide commentary on tribal business.

e. Motion to Approve the Agenda

- After the work session referenced in section b(ii), a tentative agenda shall be created including each item receiving a majority vote in the new business straw poll and each item considered old business under section (c).
- ii. After the invocation, a motion may be made to either amend or approve the tentative agenda. Either motion will pass upon a majority vote.
- iii. Once an agenda has been approved by motion, a supermajority two-thirds (e.g., five CBC members, if all seven are present) vote is required to amend the agenda.

IV. Resolutions

- a. Persons requesting to be on the agenda as new business may include a proposed resolution with their request to be on the agenda. Each person submitting a resolution to be included on the agenda shall be considered the "Sponsor" of the resolution.
- b. Sponsors of resolutions must attend the monthly CBC meeting at which such resolutions are to be considered. Sponsors shall be prepared to read their resolution in its entirety, and to field questions from the CBC and/or Tribal Council members regarding the resolution.
- c. Such resolutions shall be publicly posted⁴ on the Comanche Nation website upon receipt. If a resolution contains confidential information it is the responsibility of the sponsor to submit two versions—a confidential version and a redacted public version. The public may make comments regarding proposed resolutions by submitting those comments via email to comments@comanchenation.com. Comments shall be forwarded to the CBC and the Sponsor of the Resolution for consideration.

d. New or amended ordinances

i. Resolutions enacting new ordinances, or amending existing ordinances, require more careful consideration than other resolutions. Accordingly, prior to enacting a resolution enacting or amending an ordinance, the CBC shall make a motion to publicly post such proposed ordinance or amended ordinance on the Comanche Nation website for a period of thirty-days. During this time, the public may submit comments via email to

⁴ If a resolution contains confidential information, such as a child's name in a confidential adoption or bank account information on a signatory resolution, then the publicly posted version shall be redacted.

- comments@comanchenation.com. Comments must be submitted prior to close of business on the thirtieth day of posting.
- ii. After a proposed ordinance or amended ordinance has been posted for public comment for thirty-days, the CBC shall consider such comments and may act upon a resolution to enact the ordinance or amended ordinance.

e. Drafting tips

- i. The CBC is a body of limited authority. Each resolution must specify the source of the CBC's authority to enact the resolution. The enumerated powers of the CBC are set forth in Article VI, Section 7 of the Comanche Nation Constitution. If the source of authority is something other than Article VI, Section 7 of the Comanche Nation Constitution, the resolution may still be considered, but shall require a statement by the Tribal Attorney regarding the authority of the CBC to enact such resolution.
- ii. "WHEREAS" clauses to a resolution set forth the background and source of authority of a resolution. The legally binding portion of a resolution are the clauses that follow the statement "NOW, THEREFORE, BE IT RESOLVED."

f. Old Business

i. Resolutions that are tabled at a CBC meeting shall be placed on the agenda as old business as set forth in Section III(c) above.

V. Motions

a. Motion Passage.

i. At meetings at which a quorum is present, the CBC may pass motions. The number of in-favor votes to pass a motion shall be a majority, unless a supermajority is required by these procedures or Robert's Rules of Order.

b. Preferred and Disfavored Motions.

- Preferred motions are (I) motions governing the conduct of the meeting itself—e.g., motion to approve the agenda, motion to adjourn, motion to go into executive session, and (ii) motions to approve written resolutions.
- ii. Disfavored motions are all other motions, such as those that approve contracts, enact ordinances or codes, or to implement or administer tribal programs without a written resolution.
- iii. If a disfavored motion is made, the Presiding Officer shall inquire into why a written resolution was not submitted and should not be required.

VI. Presiding Officer and Voting

- a. The Presiding Officer for CBC meetings shall be the Chairman. If the Chairman is absent, the Presiding Officer shall be the Vice-Chairman. If the Chairman and Vice-Chairman are both absent, the Presiding Officer shall be the Secretary/Treasurer. If the Chairman, Vice-Chairman, and Secretary/Treasurer are all absent, the CBC lacks a quorum and no formal business shall be conducted.
- b. In the event that a motion or resolution (i) concerns the Presiding Officer himself or herself, (ii) substantially affects a financial interest of the Presiding Officer (other than a financial interest the Presiding Officer has solely due to membership in the Comanche Nation), or (iii) otherwise personally affects the Presiding Officer to such

a degree that the Presiding Officer subjectively feels that he or she cannot be impartial, the Presiding Officer shall temporarily recuse himself or herself as Presiding Officer.

- In the event of a temporary recusal, the Presiding Officer shall be determined as if the original Presiding Officer were absent as set forth in section VI(a) above. If the Secretary/Treasurer must recuse himself/herself temporarily, a quorum is maintained, but Committeeperson No. 1 shall temporarily serve as Presiding Officer.
- c. The Chairman shall not vote on motions unless there is a tie.
- d. If the Chairman is absent, or temporarily recuses himself/herself, the Presiding Officer may continue to exercise his/her right to vote.
- e. No member of the CBC shall vote on a motion or resolution (i) concerning himself or herself, (ii) affecting (or potentially affecting) his or her financial interests, the financial interests of an immediate family member, or the financial interests of a member of his or her household (other than financial interests solely due to membership in the Comanche Nation), or (iii) otherwise personally affecting the CBC member to such a degree that he or she cannot be impartial. In the event that such a motion or resolution is presented, the affected CBC member shall disclose his or her conflict and note his or her abstention on the record.

VII. Executive Session

- a. There shall be no presumption that executive session will be held at any CBC meeting.
- b. Executive session shall be held only upon motion and for the following reasons:
 - i. For the CBC to obtain privileged legal advice
 - ii. Discussion of trade secrets
 - Discussion of allegations of misconduct by tribal employees, officials, agents, or representatives where a false accusation of such misconduct would be defamatory
 - iv. Whistleblower complaints
 - v. Discussion of any information required to be confidential under federal or tribal law
- c. The reason(s) for a motion for executive session must be clearly stated on the record, and the attendees of executive session shall be stated except in the event of a whistleblower complaint where the whistleblower himself/herself has requested to remain confidential.
- d. Matters discussed in executive session shall be maintained confidential unless the person or organization having an interest in the confidentiality of the information waives confidentiality.

VIII. Due Process

a. Under the Indian Civil Rights Act, 25 U.S.C. § 1302(a), the Comanche Nation is prohibited from depriving any person of liberty or property without due process of law.

b. Therefore, prior to consideration of any resolution or motion that may deny a person a liberty or property interest, such person shall be given prior notice of such resolution or motion, and a meaningful opportunity to be heard.

IX. Robert's Rules

a. Robert's Rules of Order shall govern the conduct of meetings, unless inconsistent with these procedures, the Constitution of the Comanche Nation, or other laws of the Comanche Nation.

X. CBC Discretion to Suspend Rules

- a. The CBC shall have discretion to suspend or waive the requirements of Sections III-V, VII, IX of these procedures.
- b. Any action taken by the CBC without complying with Sections I(b), II(a), and VI, VIII of these procedures is null and void. Failure to comply with the formalities of any other sections of these procedures shall not affect the validity of action taken at a CBC meeting.



A RESOLUTION REMOVING AND APPOINTING TAX COMMISSIONERS

WHEREAS, the Comanche Nation is a federally recognized Indian Tribe with a Constitution approved and ratified by the Secretary of the Interior of the United States on January 9, 1967, to safeguard tribal rights, powers, and privileges to improve the economic, moral, educational, and health status of its members; and

WHEREAS, the Comanche Constitution, Article V, Section 1 provides that the supreme governing body of the Nation is the Tribal Council; and

WHEREAS, the Comanche Tribal Council enacted a General Revenue and Taxation Act (the "Tax Act") by Resolution on April 15, 1995; and

WHEREAS, the Tax Act establishes a Tax Commission that shall consist of nine enrolled tribal members who are appointed by and serve at the pleasure of the Business Committee; and

WHEREAS, the Tax Commission must consist of at least four members of the Comanche Business Committee, and the Chairman of the Comanche Nation is authorized to participate as an *ex officio* member of the Tax Commission if not otherwise appointed as a member of the Commission; and

WHEREAS, the Tax Act provides that appointment or removal from the Tax Commission shall have no force or effect until a written resolution has been filed for record in the official Tribal records; and

WHEREAS, former Chairman Mark Woommavovah and former Vice-Chairman Cornel Pewewardy served as Tax Commissioners during their time in office; and

WHEREAS, an election was held on May 17 and 18, and Forrest Tahdooahnippah was elected as Chairman and Diana Gail Doyebi-Sovo was elected as Vice-Chairman; and

WHEREAS, Chairman Tahdooahnippah and Vice-Chairman Doyebi-Sovo were sworn into office on May 24, 2024; and

WHEREAS, at the Tax Commission meeting on May 30, 2024, Vice-Chairman Doyebi-Sovo was appointed to the Tax Commission, and Chairman Tahdooahnippah was appointed ex officio; and

NOW THEREFORE BE IT RESOLVED, the former Chairman Mark Woommavovah and former Vice-Chairman Cornel Pewewardy are hereby removed from the Tax Commission; and

BE IT FURTHER RESOLVED, that Comanche Business Committee hereby ratifies and accepts the appointment of Vice-Chairman Doyebi-Sovo and *ex officio* appointment of Chairman Tahdooahnippah to the Tax Commission.

A RESOLUTION REGARDING SUPERVISION OF THE TAX ADMINISTRATOR AND TAX COMMISSION EMPLOYEES

WHEREAS, the Comanche Nation is a federally recognized Indian Tribe with a Constitution approved and ratified by the Secretary of the Interior of the United States on January 9, 1967, to safeguard tribal rights, powers, and privileges to improve the economic, moral, educational, and health status of its members; and

WHEREAS, the Comanche Constitution, Article V, Section 1 provides that the supreme governing body of the Nation is the Tribal Council; and

WHEREAS, the Comanche Tribal Council enacted a General Revenue and Taxation Act (the "Tax Act") by Resolution on April 15, 1995; and

WHEREAS, to the Tax Act establishes a Tax Commission, defines "Tax Administrator" as the business manager and/or operations manager of the Commission, and authorizes the Tax Commission to hire employees subject to Comanche Nation Human Resources; and

WHEREAS, on July 29, 2019, a memorandum was signed by three Comanche Business Committee ("CBC") members purporting to remove the Tax Commission from the direct supervision of the Tribal Administrator and place supervision "under the Executive Branch of the CBC," and

WHEREAS, on August 3, 2019, the CBC passed that gave the "Executive Branch of the CBC" direct supervision over the Tax Commission; and

WHEREAS, on October 7, 2023, the CBC passed a motion "to put the Tax Commission back under the Tribal Administrator for day-to-day oversight responsibilities;" and

WHEREAS, the CBC wishes to clarify the reporting structure and oversight of the Tax Administrator and Tax Commission employees; and

NOW THEREFORE BE IT RESOLVED, that the Tax Administrator is subject to the supervision of the Tax Commission and the Tax Commission employees are subject to the supervision of the Tax Administrator; and

BE IT FURTHER RESOLVED, that notwithstanding the foregoing, all Tax Commission employees, including the Tax Administrator, are subject to all Comanche Nation Human Resources Policies and Procedures.
