- WHEREAS, the Comanche Business Committee has been presented documentary evidence from the Comanche Nation Enrollment office, showing the adult tribal member(s) failed to comply with Resolution No. 80-17; and
- THEREFORE, BE IT RESOLVED, that the Comanche Business Committee approves Resolution No. 83-2024, List No.1335 to remove the adult tribal member(s); and

BE IT FURTHER RESOLVED, that the Comanche Nation Enrollment Office will notify the tribal member by letter of their removal from the Comanche Nation membership roll. The Comanche Nation Enrollment Office will also notify City National Bank that any current and/or previous Per-capita funds be transferred to the Comanche Nation's Unallocated Accounts.

A RESOLUTION REGARDING DRUG TESTING POLICY AND PROCEDURES

WHEREAS, the Comanche Nation is a federally recognized Indian Tribe with a Constitution approved and ratified by the Secretary of the Interior of the United States on January 9, 1967, to safeguard tribal rights, powers, and privileges to improve the economic, moral, educational, and health status of its members; and

WHEREAS, the Comanche Constitution, Article 6, Section 7(f), provides that the Comanche Business Committee has the authority to implement, administer, and report on progress of programs adopted by the Tribal Council; and

WHEREAS, the Indian Civil Rights Act provides that, in exercising powers of self-government, no Indian tribe shall violate the right of the people to be secure in their persons against unreasonable search and seizures; and

WHEREAS, Tribal employees have complained that they have been subjected to observed urinalysis drug tests;

WHEREAS, the Comanche Business Committee wishes to enact a policy for all Tribal programs that observed urinalysis drug tests are a last resort to be used only when less intrusive methods of drug testing are unavailable.

NOW THEREFORE BE IT RESOLVED, the Comanche Business Committee hereby declares that it is the policy of Comanche Nation Tribal programs that all urinalysis drug tests are to be *un*observed unless there is probable cause to believe that an employee will tamper with, or adulterate, a urine test, in which case the employee will have the option of being subject to a five-panel hair follicle test with medical officer review verification, so long as the employee has sufficient length hair for such a test, *or* an observed urinalysis;

BE IT FURTHER RESOLVED, that the Tribal Administrator is directed to amend the Human Resources policies accordingly; and

BE IT FURTHER RESOLVED, nothing herein shall be construed to otherwise alter or amend existing Comanche Nation Human Resources Policies regarding the timing or frequency of drug testing, this resolution solely affects the means and method of drug testing.

WHEREAS, the Comanche Nation is a federally recognized Indian Tribe with a Constitution approved and ratified by the Secretary of the Interior of the United States on January 9, 1967, to safeguard tribal rights, powers, and privileges to improve the economic, moral, educational, and health status of its members; and

WHEREAS, the Comanche Constitution, Article V, Section 8 provides that the Tribal Council hires an Administrator/Manager to administrate the Tribal Government; and

WHEREAS, the Tribal Council hired Lisa Dawsey an Administrator/Manager to administrate the Tribal Government via runoff election certified on June 18, 2024; and

WHEREAS, the Comanche Constitution, Article V, Section 8 provides that the Administrator/Manager shall be under the direction of the Comanche Business Committee; and

WHEREAS, the Comanche Business Committee wishes to set the salary of the Administrator/Manager in a transparent and procedurally sound manner; and

NOW THEREFORE BE IT RESOLVED, that the salary of the Tribal Administrator/Manager shall be \$100,000.00 annually; and

BE IT FURTHER RESOLVED, that in the future the Comanche Business Committee may give a performance-based raise to the Tribal Administrator/Manager via resolution; and

BE IT FURTHER RESOLVED, that the Tribal Administrator/Manager shall be entitled to a cost-of-living adjustments after one year, if the budget permits, as determined by the CBC; and

BE IT FURTHER RESOLVED, that the Comanche Business Committee shall give an annual review of the Tribal Administrator/Manager in which her performance is evaluated based on criteria to include proper management of program budgets, achievement of clean audits, timely performance of Tribal Government employee evaluations, and faithful execution of Tribal policies and procedures.

CONSTITUTION OF THE COMANCHE NATION

(As ratified November 19, 1966,

amended May 29, 1976, June 10, 1978, April 14, 1979, April 25, 1981, September 29, 1984, June 29, 1985, April 28, 1994, February 23, 2002, September 8, 2017, March 21, 2018, November 7, 2019, July 9, 2022, and December 9, 2023)

ARTICLE V — TRIBAL COUNCIL / POWERS CLAUSE

(Pursuant to Amendment I, adopted May 29, 1976, Amendment XI and Amendment XII, adopted April 14, 1979, Amendments XVIII and XIX, adopted September 29, 1984,

- (d) To authorize the expenditure of funds which may be deposited to the exclusive credit to the Comanche Nation and of funds which may be deposited to the joint credit of the Kiowa, Comanche and Apache Tribes.
- (e) To select and authorize tribal delegations to transact business on behalf of the tribe. When travel is involved, the terms of the resolution shall include the purpose of the trip and the existence of the delegation's authority.
- (f) The salariesy for the Chairman of the Business Committee, other members of the Comanche Business Committee, and other officials elected by the Tribal Council shall be established by the Tribal Council by the adoption of an annual tribal operating budget. Other than salaries approved by the Tribal Council, employee benefits available to all eligible employees, and reasonable expense reimbursements, the members of the Business Committee and other officials elected by the Tribal Council shall receive no other remuneration from the Comanche Nation or its boards, commissions, or subcommittees. and fifty dollars (\$250) per month.

ARTICLE VI – BUSINESS COMMITTEE

- Section 2. The business committee shall meet on the first Saturday of each month of each year at 10:00 a.m. In case of a legal holiday, the meeting will be held on the following Saturday. Special meetings may be called by the tribal chairman at his discretion; provided that such special meetings do not exceed a total of twenty-fourwelve (2412) meetings per calendar year.
- <u>Section 3.</u> Notice of all special meetings of the business committee shall be given by the tribal secretary-treasurer <u>via electronic communication</u> by mailing a letter or postal card to each member of the business committee at least <u>ten daysforty-eight</u> (4810) <u>hours</u> prior to the meeting date, setting forth the date, time, place, and purpose in general terms.
- <u>Section 4.</u> No action shall be taken by the business committee except when a quorum is present. A quorum shall consist of five committeemen.
- Section 5. At the beginning of each meeting of the Comanche Business Committee, the tribal secretary-treasurer, or in his absence the acting secretary as may be appointed by the tribal chairman, shall keep a record in the permanent minute book of the names of those present and those absent. If a tribal committeeman is absent for four (4) consecutive regularly scheduled meetings of the business committee, the tribal chairman shall declare his seat vacant and so notify in writing the tribal committeeman affected and steps shall be taken to fill the vacancy pursuant to Article VIII, Section 1.
- <u>Section 6.</u> All minutes of the business committee shall be published in a manner to be determined by the business committee.
- <u>Section 7.</u> The duties, responsibilities and authorities of the business committee shall include the following:
 - (a) To establish and maintain the tribal membership roll and to insure that the roll is available for inspection at all reasonable times.
 - (b) To determine qualifications of candidates nominated for office and to conduct election of tribal officers and business committeemen pursuant to the provisions of Section 2, Article VII, of this constitution.
 - (c) To execute leases, contracts or permits with regard to property which is owned exclusively or jointly by the Comanche Nation, but this does not include any jurisdiction

over individually-owned land or personal property.

- (d) To develop annual budgets for the financing of Comanche tribal operations and to present such budgets to the tribal council for final consideration as to adoption or rejection.
 - (1) The proposed annual tribal operating budget shall be disseminated to tribal members forty-five (45) days prior to the annual meeting.
 - (2) The budget shall be printed on a ballot in such a manner that each line item may be approved or disapproved by the tribal members.
 - (3) The line items of the budget shall be approved or disapproved in the election of officers conducted subsequent to the annual meeting pursuant to Article VII, Section 2, in which tribal officers are elected.
- (e) To develop proposals which are in the interest of fulling the purpose of the Comanche tribal organization including, but not limited to, programs involving employment, health, education, public relations, social, recreational, and historical activities of the tribe. Such program proposals shall be presented to the tribal council for final consideration as to adoption or rejection.
- (f) To implement, administer, and report on progress of programs adopted by the tribal council.
- (g) To appoint such subcommittees as are needed to develop the proposals suggested herein or any other worthwhile endeavors, including delegation of such authorities to these subcommittees as in commensurate with their responsibilities.
- (h) To secure an audit of each fiscal year's financial activities relating to funds from all sources, to publish the audit of the prior year's funds in the tribal newspaper and two local newspapers at least sixty (60) days prior to each annual meeting, and to prepare for delivery to those attending the annual tribal council meeting a written annual report which shall contain a synopsis of the varied activities of the business committee, the previously published audit and a forecast of activities proposed for the coming year. First audit funds shall come out of any monies available to the tribe for expenditures, including but not limited to the general budget fund or bingo fund. The audit shall be conducted by a reputable firm that is completely disassociated from any tribal member.
- (i) Such additional duties and/or responsibilities which may be assigned to the business committee by the tribal council by appropriate resolution approved in tribal council assembled.
- (j) To promulgate and enforce ordinances and codes governing law and order to protect the peace, health, safety, and general welfare on land determined to be within Comanche tribal jurisdiction.

Section 8. The term of office for each officer and committeeman shall be for a period of three (3) years or until a successor is duly elected and installed in office. Each officer or committeeman shall be eligible to serve two (2) consecutive terms effective upon date of this amendment, present term being counted as one term. At the completion of the second

consecutive term of office, an officer or a committeeman shall not be eligible for election to a position on the business committee until a period of three (3) years elapsed. In addition, an officer or committeeman who has completed two (2) consecutive terms on the business committee shall not be employed within the Comanche tribal governmental system until a period of three (3) years has elapsed. For the purpose of this section, any portion of a term shall be considered as one term.

(The petition will be declared null and void by the Enrollment Director).

- 1. Presentation of the Bill of Particulars against the accused by a representative of the accusers: This presentation shall be limited strictly to those specifics included in the Bill of Particulars as presented to the accused. See Section 2(a).

ARTICLE VIII – VACANCIES AND REMOVAL FROM OFFICE (Pursuant to Amendment XV, adopted April 14, 1979, and Pursuant to Amendment XLIV, adopted September 8, 2017, and Amendment A, adopted July 9, 2022)

AS AMENDED:

Section 1. If a committeeman or officer of the tribe shall die or resign, be removed or recalled from office, his office shall be deemed vacant and the tribal chairman, or should this office be vacant, the tribal vice-chairman, shall immediately call a meeting of the Comanche Tribal Council to be held within twenty (20) days for the purpose of filling such vacancy for the unexpired term, except that when such vacancy shall occur within four months of the annual meeting of the Comanche Tribal Council, the position shall remain vacant until the next election when provisions shall be made to fill the vacancy.

Section 2. The Comanche Tribal Council may at a meeting duly called specifically for the purpose, recall any officer or committeemen for neglect of duty or conduct that has brought disrepute upon the tribe. Such a meeting shall not be unless a petition signed by two hundred and fifty (250) eligible voters of the Comanche Nation requesting recall is submitted to the tribal chairman. The Tribal Council shall consist of all members of the Comanche Nation who are eighteen (18) years of age or older. The recall of only one officer or committeeman may be initiated per meeting called for this purpose. The petitioner's representative shall provide proper evidence or receipt by the accused, the tribal chairman shall call an official meeting of the Comanche Tribal Council within thirty (30) days for the purpose of hearing and disposition of the case, such meeting can be established within the timeframe so noted in Section 2(a)(5).

- a) Following submission of an acceptable petition for a recall Tribal Council meeting, the tribal chairman shall require that a signed Bill of Particulars setting forth the elements of neglect or misconduct be submitted to the accused. The petitioner's representative shall provide proper evidence or receipt by the accused, the tribal chairman shall call an official meeting of the Comanche Tribal Council within (30) days for the purpose of hearing and disposition of the case.
- b) Acceptable recall petitions must adhere to the following standards:
 - 1. The standards of "one and only one" recall taken on a committeeman within a 20 day timeframe; all recalls must be of a grievous nature such as mismanagement of funds, not by error, but by intent, actual manipulation of documents, coercing of personnel to perform such illegal acts, and verified not by hearsay, but with actual documents; or by intentionally misleading committeemen, committee appointees or community at large to commit acts which endanger the future appropriations of funds, notwithstanding those funds be tribal, contractual or earned revenue from the various enterprises of the Nation;

2. Include viable documentation that a crime or act is grievous enough to endengenven the Nation or its entities and was intentionally performed by the accused;

3. The particulars cannot be any subject matter not within the operational control of the accused, such as acts of nature, economic misfortune due to a national crisis, or mismanagement of program administrators (federal, state, or other contractual entity actions not within the scope of the accused), nor prior committee actions which were approved by a majority of the prior business committee members;

- 4. The presenters of the Bill of Particulars must be verified by more than 12 witnesses that they were harmed intentionally by the actions of the accused, such actions if found not viable, or true to the nature presented, such recall will be declared null and void, and presenters of the particulars will not be allowed to take a recall petition on any other committeeman for a period of months from the date the petition is filed. Their signature to any other petition will nullify such signed recall petition.
- 5. Pursuant to Tribal Council authority, a petition for recall must be accompanied with a cashier's check or bank draft of \$500.00, non-refundable, to the Enrollment Director or other designated entity so named by the Tribal Council;
- 6. No recall meeting is allowed within 45 days, prior to or after an election period is declared;
- 7. At no time will more than 2 recalls against more than 2 committee members (only one recall per person) be allowed within a 4 month period, any such filing by any member of the Nation will disqualify such person from initiating another recall for 4 months. (The petition will be declared null and void by the Enrollment Director).
- 8. No citizen of the Comanche Nation may take a recall against any committee member within months of so doing. (A member can only take out one recall on a committee member once every months.)
- 9. Subcommittee members are not subject to the recall ordinance.
- c) The format for the Tribal Council meeting shall be established as follow:
 - 1. Presentation of the Bill of Particulars against the accused by a representative of the accusers: This presentation shall be limited strictly to those specifics included in the Bill of Particulars as presented to the accused. See Section 2(a).
 - 2. The accused shall be given adequate opportunity to answer any and all charges of which he or she is accused. The accused may personally present or may choose to utilize the services of another to present this response.
 - 3. The accused while having the opportunity to rebuff the particulars, if interrupted at any time during her/his presentation **BY THE ACCUSOR OR THEIR REPRESENTATIVE**, such charges shall immediately be dismissed, without chairman's recognition, and no future charges of the same nature can be brought forth against the accused for the remainder of their term in office.
- d) Upon completion of these two presentations no further discussion shall be allowed and voting shall proceed immediately in a manner prescribed by this constitution.

e) A <u>simple</u> majority vote <u>of (50%) plus one</u> vote of those voting of the Tribal Council meeting shall be sufficient to effect recall providing a quorum is present. Should a quorum not be present the charges against the accused shall be declared null and void and no further action shall be taken on this petition. <u>REMOVE-nor shall the same charges</u> <u>be allowed within the accused officer's term of office.</u>

Section 3. Any officer or committeeman who shall be found guilty by any State or Federal Court of a felony, a grievous act involving harm or threatening harm to any other person, within or without the reservation bounds of the Comanche Nation, a misdemeanor involving dishonesty, or of accepting a bribe shall forfeit his office and such office shall immediately become vacant and be filled in accordance with Section 1 of this Article.

Discussion Topic Educational requirements for CBC Members

My reasoning for this discussion topic is to show why education is just as important as experience.

In today's rapidly evolving job market, the role of a college degree in the workplace is a topic of continuous debate. At what point does experience in a field outweigh a college degree?

Also, in the event a salary is attached to the CBC committee member positions, education degrees need to be required. In the past and present, we have members serving with no actual training in major governmental and nongovernmental entities that work closely with tribes. Members have very little knowledge of American Indian Studies or Business Administration and do not possess business management skills that focus on tribal sovereignty, tribal governance, and federal Indian law and policy.

They have no experience with the interrelationships between federal and tribal governments or the methods used by to administer programs. They have no history of federal-tribal-state relations, the roles of tribal leaders and administrators, or the laws, policies, and issues that impact tribal governments. Just merely having a career working within an hourly wage position for 40 years doesn't qualify a person to make business decisions for a 54+ million dollar business as we are. I believe this is why we are unable to move forward economically. We have unprofessionals that are stuck in the old ways of doing business where jealousy, greed, alcoholism, and corruption continue, and they have their own agendas.

A degree can show that you have the specialized knowledge and technical/management skills that our great Comanche Nation desperately needs to flourish and develop economically, as well as provide quality program services to members. As the CBC duties change on a daily basis, it is not a position that should only require minimal on-the-job training.
