RESOLUTION

- WHEREAS, the Comanche Nation is a federally recognized Indian Tribe with a Constitution approved by the Secretary of the Interior on January 9, 1967 to safeguard tribal rights, powers, and privileges to improve the economic, moral, educational, and health status of its members; and
- **WHEREAS,** the tradition of sovereignty of the Comanche Nation, since time immemorial long predates the existence of the nation, establishes the inherent sovereign powers and rights of the Comanche self-government; and
- WHEREAS, the Comanche Constitution, Article 6, Section 7(f), provides that the Comanche Business Committee has the authority to implement, administer, and report on progress of programs adopted by the Tribal Council; and
- WHEREAS, the Comanche Nation Transit Department is requesting a signature from Chairman Forrest Tahdooahnippah for the Comanche/Kiowa Split Letter. This is in order to proceed with the Federal Transit Administration FY 2025 Tribal Transit Formula Grant. This grant has been ongoing for the Comanche and Kiowa Tribes since 2008 and supports Tribal Transit in the KCA area to provide Transit access to all peoples within the KCA Region. The grant is based off of mileage of each agency that meets the goal of 200,000 Vehicle Revenue Miles per fiscal year. It is then broken down into tiers for the agencies. Tier 1 of this years' grant is \$452,122 and split between the Comanche and Kiowa agencies. Comanche Agency shall receive \$272,771 and Kiowa Agency will receive \$179,351. Tier II is granted based on meeting the goal of 200,000 Vehicle Revenue Miles and is formulated this year at \$279,059. Comanche Nation Transit qualifies for the full amount due to meeting the goal. Tier III is split evenly between the two agencies in the amount of \$300,000. Both agencies will each receive \$150,000. Grant process will be completed before September 30, 2024. The last step needed is for the Chairman to sign off on this matter; and
- WHEREAS, the Comanche Nation Business Committee has determined that it is in the best interest of the Nation for Chairman Forrest Tahdooahnippah to sign the Split Letter to proceed with FY 2025 Tribal Transit Formula Grant; and

NOW, THEREFORE, BE IT RESOLVED, that the Comanche Business Committee hereby adopts and authorized the signing of the Comanche/Kiowa split letter for FY 2025 Tribal Transit Formula Grant.

BE IT FINALLY RESOLVED THAT, the Comanche Business Committee, acting for and on behalf of the Comanche Nation, does hereby authorize this Resolution for such intent.

A RESOLUTION AUTHORIZING THE BIA ANADARKO AGENCY TO LEASE (2) TRACTS OF LAND IN COMANCHE COUNTY ACOUIRED THROUGH THE AMERICAN INDIAN PROBATE REFORM ACT

WHEREAS, the Comanche Nation is a federally recognized Indian Tribe with a Constitution approved by the Secretary of the Interior of the United States on January 9, 1967, to safeguard tribal rights, powers, and privileges to improve the economic, moral, educational, and health status of its members; and

WHEREAS, the Comanche Business Committee has the constitutional authority via Article VI, Section 7 (c) To execute leases, contracts, or permits with regard to property which is owned exclusively or jointly by the Comanche Nation, but this does not include any jurisdiction over individually-owned land or personal property; and

WHEREAS, the Comanche Business Committee has consulted with the Comanche Nation Realty Department Agriculture Specialist which has considered the terms and conditions of the five-year lease agreement and has determined that leasing these properties is in the best interest of the Comanche Nation; and

- WHEREAS, the Comanche Business Committee has determined that it is in the best interest of the Comanche Nation to authorize the BIA Anadarko Agency to lease certain real property in which the Comanche Nation has acquired undivided ownership of 50% on the following tracts:
 - 1. Contract No: 4200425685 WAP-PER Allotment, Comanche Tract 802-2395 -B (40 ac.), and Tract 802-2395-D (10ac), both tracts are located in Section 28, T4N, R12W, I.M., Comanche County, Oklahoma.

NOW THEREFORE BE IT FURTHER RESOLVED that the Comanche Business Committee hereby authorize the Comanche Nation Chairman, Forrest Tahdooahnippah, to sign the BIA Farming and Grazing Acceptance documents for the tracts listed herein, on behalf of the Comanche Nation.

NOW, THEREFORE, BE IT RESOLVED that the attached Comanche Nation Gaming Ordinance is hereby Amended and enacted; provided that such new Gaming Ordinance shall not become effective until approved by the National Indian Gaming Commission (NIGC); and

BE IT FURTHER RESOLVED the Business Committee directs the Chairman to obtain approval of said ordinance by the NIGC and to make preparations for its implementation; and

BE IT FURTHER RESOLVED that the Amended and Restated Comanche Nation Gaming Ordinance shall be in full force and effect immediately upon NIGC approval.

- WHEREAS, the Comanche Nation is a federally recognized Indian tribe with a Constitution approved by the Secretary of Interior on January 9, 1967 to safeguard tribal rights, powers, and privileges of the tribe and its members and to improve the economic, moral, educational, and health status of its members; and
- WHEREAS, the Comanche Constitution, Article V, Section 1 provides that the supreme governing body of the Nation is the Tribal Council; and
- WHEREAS, the Comanche Tribal Council enacted a General Revenue and Taxation Act (the "Tax Act") by Resolution on April 15, 1995; and
- WHEREAS, by Resolution No. 120-2020, the Comanche Business Committee added a TERO Tax to the Tax Act; and

WHERAS, the Comanche Business Committee Officers (Chairman, Vice-Chairman, Secretary/Treasurer) serve on the Tax Commission, and the CBC desires to delegate approval authority to them; and

WHEREAS, the Comanche Constitution, Article 6, Section 7(f), provides that the Comanche Business Committee has the authority to implement, administer, and report on progress of programs adopted by the tribal council; and

WHEREAS, Resolution No. 58-19 resolved that the Comanche Natural Resources program, formerly known as the Realty Program, would be under the direction of the Comanche Business Committee; and

WHEREAS, the Natural Resources Program consists of realty, land acquisition, and the cow-calf program; and

WHEREAS, the Natural Resources Program Director, Tax Administrator, and CBC Executive Assistant(s) likewise requires supervisory persons to approve budget modifications, purchase requisitions, vacation and time off, and the Comanche Business Committee desires to delegate approval authority to the Comanche Business Committee Officers; and

WHEREAS, the position description for the Executive Assistant to the CBC states that such person "reports directly to the Tribal Administrator but is assigned under the CBC," and Resolution No. 30-19 states that the Executive Assistant to the CBC is "to be placed under the CBC's supervision."; and



NOW THEREFORE BE IT RESOLVED, the Comanche Business Committee hereby delegates approval authority for budget modifications, purchase requisitions, vacation and time off to the Comanche Business Committee officers (Chairman, Vice-Chairman, Secretary/Treasurer) for the Natural Resources Director, Tax Administrator, and Executive Assistant(s) to the CBC; and

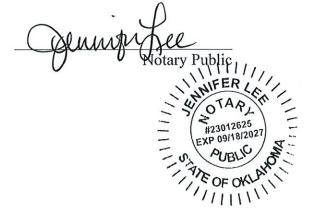

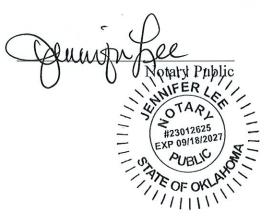
