# A RESOLUTION TO APPROVE AMENDMENTS TO THE WORKFORCE (W.I.O.A.) GUIDELINES FOR WORK EXPERIENCE

- WHEREAS, the Comanche Nation is a federally recognized Indian Tribe with a Constitution approved by the Secretary of the Interior on January 9, 1967, to safeguard tribal rights, powers, and privileges to improve the economic, moral, educational, and health status of its members; and
- WHEREAS, the Comanche Constitution, Article 6, Section 7(f), provides that the Comanche Business Committee has the authority to implement, administer, and report on progress of programs adopted by the Tribal Council; and
- WHEREAS, the Comanche Nation Constitution establishes the Comanche Business Committee as the duly elected official body designated to conduct business for and on behalf of the Comanche Nation and shall review, establish priorities, and prepare amendments to the prior guidelines created; and
- WHEREAS, the Workforce (W.I.O.A.) department has updated and will amend the written program eligibility guidelines for CNG-funded services; and
- WHEREAS, the Workforce (W.I.O.A.) department makes the following amendments to the current eligibility guidelines for CNG-funded service:
- (1) Work Experience (WE) Program
  - a. At any worksite depending on the job duties and labor, plus any credential attainments, clients pay rate will start at \$15.00 per hour and will not go over \$20.00 per hour. A matrix will be developed based on educational attainment, training completion, past work history and time been out of workforce will be considered when scoring the client for hourly rate recommendation.
  - b. Participating clients will be required to attend a one (1) day Career Development Class hosted by the Workforce staff and Local Workforce partners prior to starting at the worksite. Topics will cover Resume Building, Learning How to Budget, Dress for Success, Interview Skills, Soft Skills, Hard Skills, Focus Group Discussions, Career Assessments, Time Management, etc.
  - c. This service can now be provided once a year after a six (6) month waiting period if program is successfully completed and no employment could be obtained during six (6) month waiting period.
    - i. New worksite placement would vary to allow additional employability training or enhance current skills and to learn new skill sets.
    - ii. The client will not have the option to return to same worksite placement as before. Unless the worksite is going to train them for different position within the department to advance the skills learned in prior placement.

# COMANCHE

- Workforce will increase its timeframe from Eight (8) weeks without extension to 480 hours and/or twelve (12) weeks whichever comes first. Emergency Extensions will be granted IF the employer needs more time to hire tribal client. The request for extension must be submitted in writing prior the end date for consideration and approval by Director. Funding must be available for an extension be considered for approval.
- d. Client negligence of completing this service due to dropping out or being terminated prior to completion, will have a 2-year waiting period to 1-year waiting period and a favorable recommendation must be submitted by the Workforce Job Developer, other partner or past employer before being eligible to re-apply for services.
- e. This service is provided to clients who are unemployed, part-time and/or full-time permanent employees will not qualify.

**NOW THEREFORE BE IT RESOLVED,** that the Comanche Business Committee hereby approves the attached updated and amended Workforce (W.I.O.A.) Departmental Guidelines effective September 7, 2024.

- WHEREAS, the Comanche Business Committee will renew existing P.L. 93-638 Self-Determination Contracts for Higher Education, Adult Education, and Job Placement and Training Programs. This resolution authorizes the Comanche Nation Chairman to sign P.L. 93-638 contract renewals and/or funding agreements; and

WHEREAS, the Comanche Nation is a federally recognized Indian Tribe with a Constitution approved and ratified by the Secretary of the Interior of the United States on January 9, 1967, to safeguard tribal rights, powers, and privileges to improve the economic, moral, educational, and health status of its members; and

WHEREAS, the Comanche Constitution, Article 6, Section 7(j), provides that the Comanche Business Committee has the authority to promulgate and enforce ordinances and codes governing law and order to protect the peace, health, safety, and general welfare on land determined to be within Comanche tribal jurisdiction; and

WHEREAS, the Comanche Business Committee has promulgated a Gaming Ordinance authorizing the conduct of gaming by the Comanche Nation under the Indian Gaming Regulatory Act; and

WHEREAS, the Gaming Ordinance provides that the Nation has the sole responsibility for the conduct of gaming authorized by the Ordinance; and

WHEREAS, the Gaming Ordinance establishes Comanche Nation Entertainment as an unincorporated entity wholly-owned by the Nation; and

WHEREAS, the Gaming Ordinance requires the Comanche Nation Entertainment Chief Executive Officer to perform gaming-related duties as assigned or delegated by the Comanche Business Committee ("CBC"); and

WHEREAS, the CBC wishes to assign duties to the Chief Executive Officer in the form of express strategic direction and a priority plan; and

WHEREAS, implementation of the plan requires coordination with the Natural Resources Director, who is under the supervision of the Comanche Business Committee and who is responsible for the Nation's real property; and

WHEREAS, investments and improvements required under the plan may be subject to threat from climate change and require federal grants to address such threats; and

**NOW THEREFORE BE IT RESOLVED,** the Comanche Business Committee hereby assigns the Comanche Nation Entertainment Chief Executive Officer, the Natural Resources Director, and itself the duty of implementing the following priority plan:

WHEREAS, the Comanche Nation is a federally recognized Indian Tribe with a Constitution approved and ratified by the Secretary of the Interior of the United States on January 9, 1967, to safeguard tribal rights, powers, and privileges to improve the economic, moral, educational, and health status of its members; and

WHEREAS, the Comanche Nation Constitution, Article VI, Section 7(j) provides that the Comanche Business Committee has the authority to promulgate and enforce ordinances and codes governing law and order to protect the peace, health, safety, and general welfare on land determined to within Comanche tribal jurisdiction; and

WHEREAS, to promote the general welfare and improve the economic status of tribal members, the Comanche Business Committee has enacted a Gaming Ordinance approved by the National Indian Gaming Commission; and

WHEREAS, the Gaming Ordinance establishes Comanche Nation Entertainment as an unincorporated entity wholly-owned by the Nation; and

WHEREAS, the Gaming Ordinance requires the Comanche Nation Entertainment Chief Executive Officer to perform gaming-related duties as assigned or delegated by the CBC; and

WHEREAS, Section 316 of the Gaming Ordinance, and its predecessors, provides that the Commission shall develop a budget to be approved by the Comanche Business Committee; and

WHEREAS, in prior fiscal years, budgeted funds that were not expended were reserved and not allocated or spent; and

WHEREAS, the reserved funds have accumulated to the sum of	and

WHEREAS, the funds originated as gaming revenue, and the Nation's gaming facilities need improvements and renovations; and

WHEREAS, the Comanche Business Committee has determined it is in the best interest of the Nation for the Gaming Commission to reserve of the accumulated funds in case of budget shortfall, and for the remaining funds to be transferred to Comanche Nation Entertainment for capital expenditures at the beginning of the fiscal year 2025; and

NOW THEREFORE BE IT RESOLVED, the Comanche Business Committee hereby directs the Gaming Commission to transfer from the bank account ending in -3327 to Comanche Nation Entertainment on October 1, 2024; and

**BE IT FURTHER RESOLVED,** that the Chief Executive Officer of Comanche Nation Entertainment is hereby assigned the duty of using such funds for capital expenditures listed on the August monthly report to the Business Committee to include at least a pool at the Red River Hotel and Casino, raised flooring at the Red River Hotel and Casino, and raised flooring at the Comanche Nation Casino.

# A CBC RESOLUTION AUTHORIZING AND APPROVING COMANCHE NATION ENTERTAINMENT FY2025 OPERATING BUDGET

WHEREAS, the Comanche Nation is a federally recognized Indian tribe with a Constitution approved by the Secretary of Interior on January 9, 1967, to safeguard tribal rights, powers, and privileges of the tribe and its members and to improve the economic, moral, educational, and health status of its members; and

WHEREAS, the Comanche Nation Constitution, Article VI, Section 7 establishes the Comanche Business Committee as the duly elected official body designated to conduct business for and on behalf of Comanche Nation in a legal quorum; and

WHEREAS, the Comanche Nation Gaming Ordinance (Ordinance), at Section 207(C) CEO duties, "develop, approve, and present to the CBC, the Annual Operating Budget for CNE in accordance with Section 211 of this ordinance and implement and manage such budget; and

# A RESOLUTION AUTHORIZING USE OF FUNDS

WHEREAS, the Comanche Nation is a federally recognized Indian Tribe with a Constitution approved and ratified by the Secretary of the Interior of the United States on January 9, 1967, to safeguard tribal rights, powers, and privileges to improve the economic, moral, educational, and health status of its members; and

WHEREAS, the Comanche Constitution, Article V, Section 6(d) provides that the Comanche Tribal Council has the exclusive authority to authorize expenditure of funds deposited to the exclusive credit of the Comanche Nation; and

WHEREAS, the Comanche Constitution, Article VI, Section 7(d), provides that the Comanche Business Committee must develop an annual budget and present it to the Tribal Council for final consideration as to adoption or rejection; and

WHEREAS, the Comanche Constitution, Article VI, Section 7(f), provides that the Comanche Business Committee has the authority to implement, administer, and report on progress of programs adopted by the Tribal Council; and

WHEREAS, each year the Comanche Tribal Council approves an annual budget consisting of funds earned by the Tax Commission and the Tribe's gaming operations, and in some years the Tribe's tobacco businesses; and

WHEREAS, tribal programs receive additional funding from grants, federal self-determination contracts, or earned income; and

WHEREAS, as a result, tribal programs do not always expend the entire amount of funds approved by the Tribal Council in the annual budget; and

WHEREAS, previously gaming revenue, tax revenue, and earned income not expended by Tribal programs became part of a charitable fund for the Comanche Chairman; and

WHEREAS, the Chairman's charitable fund was stopped in the fiscal year beginning October 1, 2016; and

WHEREAS, unspent budgeted funds and unspent earned income between October 1, 2016 to September 30, 2018 were distributed as a "dividend;" and

WHEREAS, some dividend checks were returned, and as a result, the Nation currently has a "Revenue Share Excess Distribution" account (xxx0793); and

WHEREAS, since the "dividend" unspent budgeted funds have been accumulating in the Nation's Tribal Operations account; and

WHEREAS, some of the unspent budgeted funds are gaming revenue subject to the Nation's Revenue Allocation Plan; and

# COMANCHE

WHEREAS, under the Revenue Allocation Plan ("RAP"), 40% of net gaming revenue goes to the per capita and elder's payments, 10% of net gaming revenue goes to tribal government, 25% of net gaming revenue goes to community and education; and

WHEREAS, of the unspent budgeted funds that consist of gaming revenue, 16% comes from tribal government programs, about 36% comes from economic development programs, and about 48% comes from community and education programs, or in other words, measure in terms of net revenue, 9.8% comes from tribal government programs (compared to 10% called for by the RAP), 21.5% comes from economic development programs (compared to 25% called for by the RAP), and 28.7% comes from community and education programs (compared to 25% called for by the RAP); and

WHEREAS, the Revenue Allocation Plan permits the Comanche Business Committee to move not more than ten percent of funding provided in each category to any other category if the funding in the category from which the money is being taken is not necessary for the stated purposes, and if the funding is required for the category into which the money is being transferred; and

WHEREAS, due to increased competition in the gaming industry, and higher than anticipated costs in the construction of the Cache Casino, the net revenue generated in the current fiscal year is less than the million anticipated at the 2023 Annual Meeting of the Tribal Council; and

WHEREAS, due to lower than anticipated revenue in the prior fiscal year due to the COVID19 pandemic, the Tribal programs had to make a repayment to the Tribe's gaming operations in the amount of in the current fiscal year; and

WHEREAS, in order to make up the deficit, rather than having the casino cut expenses and forego needed capital improvements, the Comanche Business Committee desires to use the "Revenue Share Excess Distribution" and prior years' unspent budgeted funds, including gaming funds, which the Comanche Business Committee finds it may make an adjustment consistent with the Revenue Allocation Plan such that economic development is adjusted from 9.8% back to 10%, economic development is adjusted from 21.5% back to 25% and community and education is adjusted from 28.7% back to 25%; and

**NOW THEREFORE BE IT RESOLVED**, that the Comanche Business Committee hereby authorizes the transfer of all funds in the a "Revenue Share Excess Distribution" account (xxx0793) to the Tribal Operations account for use, pro rata, across all Tribal programs funded by gaming revenue; and

**BE IT FURTHER RESOLVED,** that the Comanche Business Committee hereby authorizes the use, pro rata across all Tribal programs funded by gaming revenue, of from prior years' unspent budgeted funds.

**NOW THEREFORE BE IT RESOLVED,** the Comanche Business Committee hereby creates a "National Treasure" designation; and

**BE IT FURTHER RESOLVED**, that the "National Treasure" designation is reserved for Tribal members over the age of fifty that have made major contributions over a significant period of their lifetime to perpetuating the Comanche culture; and

**BE IT FURTHER RESOLVED,** that hereafter two "National Treasures" shall be designated at the September regular monthly Comanche Business Committee meeting from nominations submitted to the Comanche Business Committee on or before July 1 of each year; and

**BE IT FURTHER RESOLVED,** that a permanent location for display shall be created at the museum at a location to be determined at a future time by the Comanche Business Committee; and

**BE IT FURTHER RESOLVED**, that Geneva Navarro and Rance Hood are hereby designated as the inaugural Comanche National Treasures.

WHEREAS, Comanche Construction LLC did not adequately address issues, and the Comanche Nation has had to pay for other contractors to remedy the poor workmanship of Comanche Construction LLC or its subcontractors; and

WHEREAS, Comanche Nation staff have complained that Comanche Construction LLC's principals and agents have not engaged in respectful dialogue during construction of the child care facility; and

WHEREAS, doing business with the Comanche Nation and being paid with Comanche tribal funds are a privilege; and

**NOW THEREFORE BE IT RESOLVED,** the Comanche Business Committee determines that it is not in the best interests of the health or welfare of the Tribe for Comanche Construction LLC, or any of its related entities, to serve as a vendor for the Comanche Nation or its related entities; and

**BE IT FURTHER RESOLVED,** that the Comanche Business Committee hereby prohibits any Tribal program, any Tribally-owned entity, and/or any Tribally-funded entity from engaging, retaining, and/or otherwise doing business with Comanche Construction LLC or any of its related entities.

WHEREAS, the health and welfare of Tribal members will be improved with a more reliable food supply, especially of nutritious traditional foods or traditional plant medicines; and

WHEREAS, traditional foods, such as yapa root, and traditional plant medicines, such as peyote, require different climates than that which exists in Southwest Oklahoma and the availability of traditional foods and plant medicines can be enhanced using greenhouses; and

**WHEREAS**, the health and welfare of Tribal members will be improved with a more reliable food supply, especially through reliable raising of livestock.

**NOW THEREFORE BE IT RESOLVED** that the Comanche Business Committee hereby approves the Chairman to request supplemental funding from the Bureau of Indian Affairs for special projects as follows:

- \$150,000 to purchase used pickup trucks to add to the Tribe's vehicle fleet;

- \$50,000 for fence posts and barbed wire.

# A RESOLUTION AMENDING ELECTION ORDINANCE

WHEREAS, the Comanche Nation is a federally recognized Indian Tribe with a Constitution approved and ratified by the Secretary of the Interior of the United States on January 9, 1967, to safeguard tribal rights, powers, and privileges to improve the economic, moral, educational, and health status of its members; and

WHEREAS, the Comanche Nation Constitution, Article VI, Section 7(j) provides that the Comanche Business Committee has the authority to promulgate and enforce ordinances and codes governing law and order to protect the peace, health, safety, and general welfare on land determined to within Comanche tribal jurisdiction; and

**WHEREAS**, the Comanche Business Committee previously adopted an Election Ordinance on February 3, 2024 by Resolution No. 22-2024; and

WHEREAS, the Election Ordinance includes the following quorum requirement in Section 202(b)(1);

For the Election Board to take any official action at a meeting, the meeting must have a valid quorum. For any meeting occurring before the 2024 General Election, quorum is met if there are four (4) Election Board members present. For any meeting occurring after the 2024 General Election, quorum is met if there are ten (10) Election Board members present.

WHEREAS, only ten persons currently serve on the Election Board, and the Election Board has failed to meet quorum at recent meetings; and

WHEREAS, to promote the general welfare and improve the economic status of tribal members, the Comanche Business Committee desires to amend the Election Ordinance to decrease the quorum requirement to two-thirds (2/3rds) of seated Election Board members; and

WHEREAS, this amendment is exigent, the Election Board must elect new officers, develop a budget for the fiscal year beginning October 1, staff the Election Office, and conduct other business; and

WHEREAS, as a result of the exigency, a thirty-day notice and comment period is not practicable and is waived; and

**NOW THEREFORE BE IT RESOLVED,** the Section 202(b)(1) of the 2024 Election Ordinance is hereby amended to recite the following:

For the Election Board to take any official action at a meeting, the meeting must have a quorum. A quorum is met if two-thirds (2/3rds) or more of seated Election Board members are present. For purposes of computing quorum, vacant seats shall be disregarded.

**BE IT FURTHER RESOLVED,** that the Tribal Administrator is directed to ensure that all posted copies of the Election Ordinance are amended accordingly.

# A RESOLUTION PROPOSING AMENDMENT TO CONSTITUTION TO REMOVE SECRETARIAL ELECTIONS

WHEREAS, the Comanche Nation is a federally recognized Indian Tribe with a Constitution approved and ratified by the Secretary of the Interior of the United States on January 9, 1967, to safeguard tribal rights, powers, and privileges to improve the economic, moral, educational, and health status of its members; and

WHEREAS, the Comanche Constitution, Article IV, Section 1 recognizes the Comanche Tribal Council as the supreme governing body of the Comanche Nation; and

WHEREAS, at the Annual Meeting of the Tribal Council held on April 20, 2024, a Tribal Council Resolution was proposed, Resolution TC 03-2024, and was subsequently approved by the Tribal Council in the 2024 General Election with a vote of 771-Yes (63.04%) and 452-No (36.96%); and

WHEREAS, Resolution TC 03-2024 calls for an amendment to Article XIII, ADOPTION; and

WHEREAS, the intent of the author of Resolution TC 03-2024 was for an amendment to Article XI, AMENDMENTS; and

WHEREAS, in particular, the author of the Resolution desired to remove the requirement of a Secretarial Election for an amendment to the Constitution, and instead allow the Constitution to be amended via Tribal Election; and

WHEREAS, the Comanche Constitution, Article XI, Section 1, provides that amendments to the Constitution may be proposed by a majority vote of the Business Committee; and

WHEREAS, the Comanche Business Committee believes it was the intent of the Tribal Council to request an amendment to the Constitution to remove the requirement for a Secretarial Election for amendments, and wishes to give effect to this intent; and

**NOW THEREFORE BE IT RESOLVED,** the Comanche Business Committee hereby proposes that the following Constitutional provision, ARTICLE XI—AMENDMENTS, which reads as follows:

<u>Section 1.</u> Amendments to this constitution may be proposed by a majority vote of the business committee or by a petition signed by two hundred (200) adult members of the tribe who are entitled to vote, and if approved by the Commissioner of Indian Affairs, shall be submitted to the voters of the Tribe, and shall become effective when ratified by a majority vote of those who cast ballots in an election called by the Commissioner of Indian Affairs.

### be amended as follows:

Section 1. Amendments to this Constitution may be proposed by a majority vote of the Business Committee or by a petition signed by two hundred (200) adult members of the tribe who are entitled to vote. Such proposals shall be submitted to the voters of the Tribe, and shall become effective when ratified by a majority vote of those who cast ballots in an election.



**BE IT FURTHER RESOLVED,** this Amendment shall be submitted to the Commissioner of Indian Affairs for approval.

# COMANCHE NATION TRIBAL COUNCIL RESOLUTION To Propose Constitutional Change to Article XIII Adoption, Section 1

- whereas, the Comanche Nation is a federally recognized Indian Tribe with a Constitution approved and ratified by the Secretary of the Interior of the United States on January 9, 1967, to safeguard tribal rights, powers, and privileges to improve the economic, moral, educational, and health status of its members; and
- **WHEREAS,** as defined in the Comanche Constitution Article IV§1 the Supreme Governing Body of this organization shall be the Comanche Tribal Council; and
- WHEREAS, the Comanche constitution, Article IV, Section 1, establishes the supreme governing body of the nation shall be the Comanche tribal council, thereby establishing that amendments to the Nations' Constitution, can be presented and approved by majority vote of the tribal council; and
- WHEREAS, the Comanche Constitution, Article XIII, ADOPTION, section 1 reads as follows:

Section 1. This constitution shall become effective when approved by the Commissioner of Indian Affairs and ratified by a majority vote of the eligible voters of the Comanche Nation voting in an election called by the Commissioner; provided, that at least thirty (30) percent of those eligible to vote cast ballots; and

# to be amended as follows:

<u>Section 1.</u> This constitution shall be amended by the ratification of a majority vote of the eligible voters of the Comanche Nation voting population in an election called by the tribal council, provided that at least thirty (30) percent of the eligible voters cast ballots.

**NOW THEREFORE BE IT RESOLVED,** the Comanche Tribal Council ordains that the Comanche Constitution amend Article XIII, Section 1, ADOPTION to read: This constitution shall be amended by the ratification of a majority vote of the eligible voters of the Comanche Nation voting population in an election called by the tribal council, provided that at least (30) percent of the eligible voters cast ballots.

**BE IT FURTHER RESOLVED,** the recommended amendment to Article XIII, Section 1, must be approved by a *secretarial election* of the tribal council and ratified by the regional director of the BIA in accordance of article XI (11), Section 1, to amend in the Comanche Constitution.

# **CERTIFICATION**

The foregoing resolution was adopted and passed by referendum vote at large by the Comanche Nation Tribal Council by a General Election held on May 18, 2024, by a majority vote of 771 for and 452 against.

# Resolution to Support the Legislation to Create the Truth and Healing Commission on Federal Indian Boarding School Policies Act in the United States

WHEREAS, attempts to destroy Native cultures, religions, and languages through assimilationist practices and policies can be traced to the early 17th century and the founding charters of some of the oldest educational institutions in the United States; and

WHEREAS, the Federal Indian Boarding School Policy was expressly intended to accomplish genocide—the systematic destruction of Indigenous identities and beliefs, and taking of Native lands; and

WHEREAS, between 1819 and the 1960s hundreds of thousands of American Indian, Alaska Native, and Native Hawaiian children were removed from their homes and families and placed in Indian boarding schools operated by the federal government and churches; and

WHEREAS, many of the children who were taken to Indian boarding schools did not survive, and of those who did survive, many never returned to their parents, extended families, or communities; and

WHEREAS, many of the children who were taken to Indian boarding schools did not survive were interred in cemeteries and unmarked graves; and

WHEREAS, American Indian, Alaska Native, and Native Hawaiian communities continue to experience intergenerational trauma and cultural and familial disruption from experiences rooted in Indian Boarding Schools Policies, which divided family structures, damaged cultures and individual identities, and inflicted chronic physical and psychological ramifications on American Indian, Alaska Native, and Native Hawaiian children, families, and communities; and

WHEREAS, the descendants of these children, spanning across multiple generations, bear the legacy of Indian boarding schools and the enduring federal policy that established and perpetuated them, wherein the trauma they endured remains unacknowledged and unresolved to this day; and

WHEREAS, many of the children who were taken to Indian boarding schools and did not survive were interred in cemeteries and unmarked graves; and the children who perished in neighboring hospitals and other institutions were buried in on-campus and off-campus cemeteries and unmarked graves; and

WHEREAS, parents of children who were forcibly removed from or coerced into leaving their homes and placed in Indian boarding schools were prohibited from visiting or engaging in correspondence with their children; and

# COMANCHE

WHEREAS, parental resistance to compliance with the harsh, no-contact policy of Indian boarding schools resulted in parents being incarcerated or losing access to basic human rights, food rations, and clothing; and

WHEREAS, the federal government has a responsibility to fully investigate its role in, and the lasting effects of, Indian Boarding School Policies; and

WHEREAS, the survivors of Indian boarding schools are victims of crimes that the United States has never acknowledged or accounted for; and

WHEREAS, the facts and history about the pervasive harm caused continues in the historical and intergenerational trauma attributable to the Boarding School Policy and is poorly understood by the American public, the Congress and the Executive Branch of the federal government; and

WHEREAS, it has been identified that 526+ Indian boarding schools existed across 38 states but this does not include day schools, asylums, orphanages, and hospitals that were used to take Native children from their family and Tribes during this same time period; and

WHEREAS, to support the establishment a Truth and Healing Commission on Indian Boarding School Policies in the United States, including other necessary advisory committees and subcommittees to:

- formally investigate, document, and report on the histories of Indian boarding schools, Indian Boarding School Policies, and the systematic and long-term effects on Native American peoples;
- to develop recommendations for federal action based on the findings of the Commission;
- to promote healing for survivors of Indian boarding schools, the descendants of those survivors, and the communities of those survivors; and

**THEREFORE, BE IT RESOLVED**, that the Comanche Nation does hereby support the "Truth and Healing Commission on Indian Boarding Schools Policies in the United States Act" (S.1723 and H.R. 7227);

**BE IT FURTHER RESOLVED**, the Comanche Nation urges the House and Senate to pass S. 1723 and H.R. 7227;

**BE IT FURTHER RESOLVED**, the Comanche Nation calls on President Joe Biden and Interior Secretary Debra Haaland to garner the full authority of the Biden Administration to support these bills.

# A RESOLUTION STATING THAT THE COMANCHE LANGUAGE DEPARTMENT IS THE OFFICIAL ENTITY AUTHORIZED TO CONDUCT LANGUAGE ACTIVITY ON BEHALF OF THE COMANCHE NATION

WHEREAS, the Comanche Nation is a federally recognized Indian Tribe with a Constitution approved and ratified by the Secretary of the Interior of the United States on January 9, 1967, to safeguard tribal rights, powers, and privileges to improve the economic, moral, educational, and health status of its members; and

WHEREAS, the Comanche Constitution, Article V, Section 1 provides that the supreme governing body of the Nation is the Tribal Council; and

WHEREAS, the Comanche Tribal Council approved a motion made by Geneva Navarro and seconded by Rita Barnhart on April 16, 2005 for the "centraliz[ation] and consolidat[ion of] all language activity;" and

WHEREAS, in the 2018 General Election, the Tribal Council approved a budget for Comanche Language Planning and Development for Fiscal Year 2019 and subsequently approved funding in Fiscal Years 2020-2023; and

WHEREAS, at the 2018 Annual Meeting of the Tribal Council, a presentation by the Comanche Language Planning and Development Team emphasized that the purpose of the team was to "plan for [a] new language department" and that the budget was "the beginning phase of designing a multifaceted Comanche language department *under tribal governance*" (emphasis added); and

WHEREAS, the Comanche Language Department envisioned by the Comanche Language Planning and Development Team came to fruition in 2019; and

WHEREAS, the Comanche Language Department is a department of the Comanche Nation and has received funding under the name Comanche Language Department since 2024; and

WHEREAS, prior to the formation of the Comanche Language Department, a state-chartered organization, the Comanche Language and Cultural Preservation Committee (CLCPC) was formed in 1994; and

WHEREAS, the Comanche Language and Cultural Preservation Committee received Tribal Council approved funding to create and develop Comanche language materials from at least 2005 until 2019; and

WHEREAS, the existence of at least three separate entities concerning Comanche language—the Comanche Language and Cultural Preservation Committee, the Comanche Language Planning and Development Team, and Comanche Language Department—on Tribal Council budgets at different, and sometimes overlapping, time periods has created some level of confusion as to what entity is the "official" entity for the Comanche language; and

WHEREAS, disputes concerning intellectual property ownership of language materials have arisen throughout Indian Country where Tribes have worked with non-Tribally chartered organizations; and

# COMANCHE

WHEREAS, the Comanche Constitution, Article VI, Section 7(f) provides that the Comanche Business Committee has the authority to implement, administer, and report on progress of programs adopted by the Tribal Council; and

WHEREAS, to avoid any confusion regarding what organization is the official entity conducting Comanche language activity on behalf of the Nation, to carry out the intent of the Tribal Council to consolidate language activity, to safeguard the property rights of the Nation, and to protect the sovereignty of the Comanche Nation as it concerns the Comanche language, the Comanche Business Committee desires to approve the following resolution; and

NOW THEREFORE BE IT RESOLVED, that the Comanche Business Committee hereby reinforces, declares, and emphasizes that the official entity authorized to conduct language activity on behalf of the Comanche Nation is the Comanche Language Department; and

BE IT FURTHER RESOLVED, that all Tribal programs, subsidiaries, departments, divisions, instrumentalities, or other entities receiving Tribal funds are directed to work solely with the Language Department, or the designees of the Language Department, for matters concerning the Comanche Language; and

BE IT FURTHER RESOLVED, that the Language Department is hereby directed to develop processes and procedures for protecting the Nation's intellectual property and promoting the Nation's data sovereignty, including defense of the Nation's federal copyrights to language materials, defense of the Nation's other property rights to language materials, certification of language speakers, purchase and distribution of language materials created by Tribal members, negotiation of royalties for the Nation from translation of works for third-parties, and licensure of educational uses of language materials owned by the Comanche Nation; and

**BE IT FURTHER RESOLVED,** that nothing herein shall abridge the rights of Tribal members to freedom of worship, conscience, speech, press, assembly, and association under the Comanche Constitution.
